

Southern Illinois Regional EMS System

I-10 EMT/PARAMEDIC REINSTATEMENT

- An Illinois licensed Emergency Medical Technician or Paramedic whose license has been expired for less than 36 consecutive months may apply for EMS license reinstatement with The Southern Illinois Regional EMS System and the Illinois Department of Public Health.
 - The EMS MD has the right to accept or reject any and all reinstatement applications.
- Requirements of the candidate for EMS license reinstatement:
 - Submit a letter of request for reinstatement to the EMS System.
 - Current AHA Healthcare Provider CPR card.
 - Provide proof of completion of a minimum required EMS continuing education hours.
 - Hours must be completed within 36 months of reinstatement application.
 - Successful completion of psychomotor requirements for appropriate license level.
 - Skills must be completed within 12 months of reinstatement application.
 - EMT Psychomotor Requirements:
 - Bleeding Control – Shock Management
 - BVM Apneic Patient
 - Cardiac Arrest Management – AED
 - Joint Immobilization
 - Long Bone Immobilization
 - Oxygen Administration
 - Patient Assessment (medical and trauma)
 - Spinal Immobilization (seated and supine)
 - Paramedic Psychomotor Requirements:
 - Alternative Airway Device (supraglottic airway)
 - Bleeding Control – Shock Management
 - Cardiac Arrest Management
 - Dynamic Cardiology
 - Intravenous Therapy
 - Intraosseous Infusion
 - Joint Immobilization
 - Long Bone Immobilization
 - Patient Assessment (medical and trauma)
 - Pediatric Respiratory Compromise
 - Pediatric Ventilatory Management
 - Spinal Immobilization (seated and supine)
 - Static Cardiology
 - Ventilatory Management – Adult
 - Pay a reinstatement fee in the amount prescribed by IDPH.
 - In the form of a money order, cashier's check, or organization's check.
 - Make check or money order payable to: Illinois Department of Public Health.
- Requirements of the EMS System for EMS license reinstatement:
 - Verification of continuing education requirements.
 - Administration of psychomotor testing.
 - Testing administered by EMS MD, EMS System Administrator, EMS Coordinator, or approved EMS System Preceptor.
 - OR proof of successful completion of NREMT psychomotor testing within the last 12 months.

I-10 EMT/PARAMEDIC REINSTATEMENT (continued)

- Verify the personal history statement is completed.
 - If “yes” is answered, an authorization of release of information and criminal history report will be required (at additional cost to candidate).
- Letter of recommendation from the EMS MD verifying the requirements were completed and attesting to the eligibility of the candidate for EMS testing.
- A valid EMS license will be issued by IDPH after all of the above mentioned requirements are met and the candidate successfully completes the appropriate State of Illinois EMS exam.
 - If the candidate chooses to participate in the Southern Illinois Regional EMS System after licensure, they will be required to meet the EMS System Plan orientation requirements.
